


Fred J. Knorr, 32 years of age, the old-est mail clerk in the United States, a veteran of the Union army during the sectional war, and one of the best-known estimate war, and one of the dest-known citizens of this city, died of Bright's dis-case at his home, 534 East Gray street, at 5:30 o'clock this morning after an Elness of several days.

Col. Knorr, as he was affectionately

known by his friends, was a native of Wurtemburg, Germany, and was born September 1, 1823. In his youth he served in the German army, and at the age of 23 years he came to America and made his home in Louisville. At the beginning of the sectional war he enlisted in the Sixth Indiana Volunteer Infantry and when Indiana Volunteer Infantry and when this regiment was mustered out he joined the Thirty-second Indiana Volunteer In-fantry.

Enlisting as a private, he gained pro-motion by his merit, and finally was browtied a Lieutenant for gallantry in

provetted a Lieutenant for Salianity in action. Among the battles in which he fought were ShiCoh. Stone River, Corinth, Mis-sionary Ridge, Chickamauga and the siege of Knoxville. He was also with Sherman in his march to the sea, He was wounded at the battle of Stone River, and his life was saved by a silver watch he wore, the built striking the watch and spending its force upon it. The builet-plerced watchcase he carried with him always afterward. Col. Knorr entered the mail service at the Louisville post-office in Actober, 1570, and served continually since that time; never missing a day except in cases of

sickness. He was able to attend to the duties of his office until Thursday of last week. He was a member of the G. A. Ri-He martled, in 1852, Mrs. Margaret Hill Larsen, widow of Peter Lersen. Since her death, six years ago, he has made his home with his step-daughter, Miss Carre Larsen, 524 Gray street. He is sur-vived by two sons, Dr. George Knorr, Al-bert Lea, Minn., and Fred J. Knorr, Jr., Gillett, Ark.; four daughters, Mrs. D. D. Fallie, of New Mexico: Mrs. D. L. May, Elizabethown; Mrs. Lawrence Long and Mrs. Edward Nord, 524 Gray street, Lou-isville, and the step-daughter, Miss Lar-sen.
